Trout Unlimited is a volunteer-driven organization from the State Chair down to the casual member. Without volunteers there would be no trout and wildlife habitat improvements, no Trout In The Classroom, no summer fishing camp for kids, no fly tying classes, no newsletters, well you get it.

In my introductory column last Spring, I cited my role as president as that of an advocate bringing diverse groups together to work toward the common cause of conserving clean cold water, and that will continue, for certain. An additional responsibility in my new role is to develop and administer opportunities for our members to volunteer their time. Historically our chapter-volunteer events have been limited to brute-force work days and tackle-oriented programs, which will continue, but these aren't necessarily venues amenable to all of the membership. There will be opportunities to volunteer in an educational capacity, working in schools and at summer-fishing camp events with the next generation of land and water stewards. I would like to see a late-winter fishing-conservation event with programs and displays, boy could we use the help there.

My own list of potential events, programs and community outreach is a long one but what I really want to see is your list, seriously. Please send me your ideas for anything chapter related ... programs, guest speakers, demonstrators, retailers, field trips, etc ... And don't be bashful, hatching up a new idea doesn't mean you'll be stuck with it. It's in the military where the saying "never volunteer" is applicable, but in TU "volunteer and have some fun" is the order of the day.

After attending his first work day here's what Dan Braun, a Sauk County trout enthusiast, had to say: *"Getting out onto a stream to do this type of work was a lot more fun than I could have imagined. Driving to the site in the storm, I kept checking my e-mail to see if the work day would be called off. In reality, when I arrived, the parking lot was full and several of us had to park out on the road! Despite the rain, I heard laughter from the work site as I scrambled to get my waders on. The atmosphere was extremely friendly and energetic. And let me tell you, it is a great pleasure to destroy plants that take flies and lures!"*

**Trout In The Classroom in Reedsburg** – Trout In The Classroom, an educational outreach program of Trout Unlimited, will be starting in Reedsburg at Pineview Elementary School in Fall of 2015. Two fifth-grade classrooms, funded by grants from Alliant Energy and the School District of Reedsburg, will receive cold-water, 55-gallon aquariums specifically designed to rear trout from eggs to fingerlings.

This program will be integrated into the Science Technology Engineering and Math (STEM) curriculum in these two classrooms. The students will learn about the life cycle and ecology of trout and the importance of cold water and habitat. To control the spread of disease and invasives, no wildlife of any species can be released from captivity into the wild, therefore the fingerlings will be released into an approved pond in the Spring.

**Fly Fishing 101** – In collaboration with Orvis of Middleton, ALCTU will be hosting Fly Fishing 101, an introductory class, in early Spring 2016. There is no fee and attendees will be given a free one year TU membership. We would like to time this offering with our fly tying classes so that someone new to the sport will know the ins and outs of the "knots and hackle" before fishing season opens. We will have dates and locations established for the Fall newsletter.

**Summer Fishing Camp** – Wisconsin Trout Unlimited will host a summer fishing camp for kids aged 12 to 16 at Pine Lake Bible Camp near Waupaca. Each chapter can sponsor one kid to attend the camp with a maximum of 15 campers. This year's camp is being held from July 16th to 19th. This is the second year for the camp therefore we want to give anyone interested plenty of time to plan in advance for the 2016 camp. We will provide updated information later in the year for the 2016 camp.
